Dear Past or Potential Farmer's Market Participant:

Welcome to the 2019 Clintonville Farmer's Market! The Market is now running under the direction of the Clintonville Area Chamber of Commerce. The Market will continue to take place on Thursdays from 3:00 to 7:00 pm beginning June 20, 2019 and weather permitting continue through October 10, 2019. The Market will remain located in the parking lot of the Clintonville Community Center at 30 S. Main St.

On the back of this letter you will find a map that you may use to choose a site for the upcoming year. Site numbers with an "E" behind them will have access to electricity. You will be required to provide your own extension cords for these sites. Sites will be assigned on a first come, first serve basis. You may choose to pay a seasonal fee of \$50.00, which will include a season pass and a reserved lot. You may also choose to purchase a weekly pass for \$5.00 (per week). These passes will not have a reserved location. If after attending the Market on a weekly pass, you decide to purchase an annual pass the cost will be prorated. For new weekly vendors, the first Market is free.

A copy of the Market guidelines has been included with your application. Please read these carefully. By signing the application you agree to these terms.

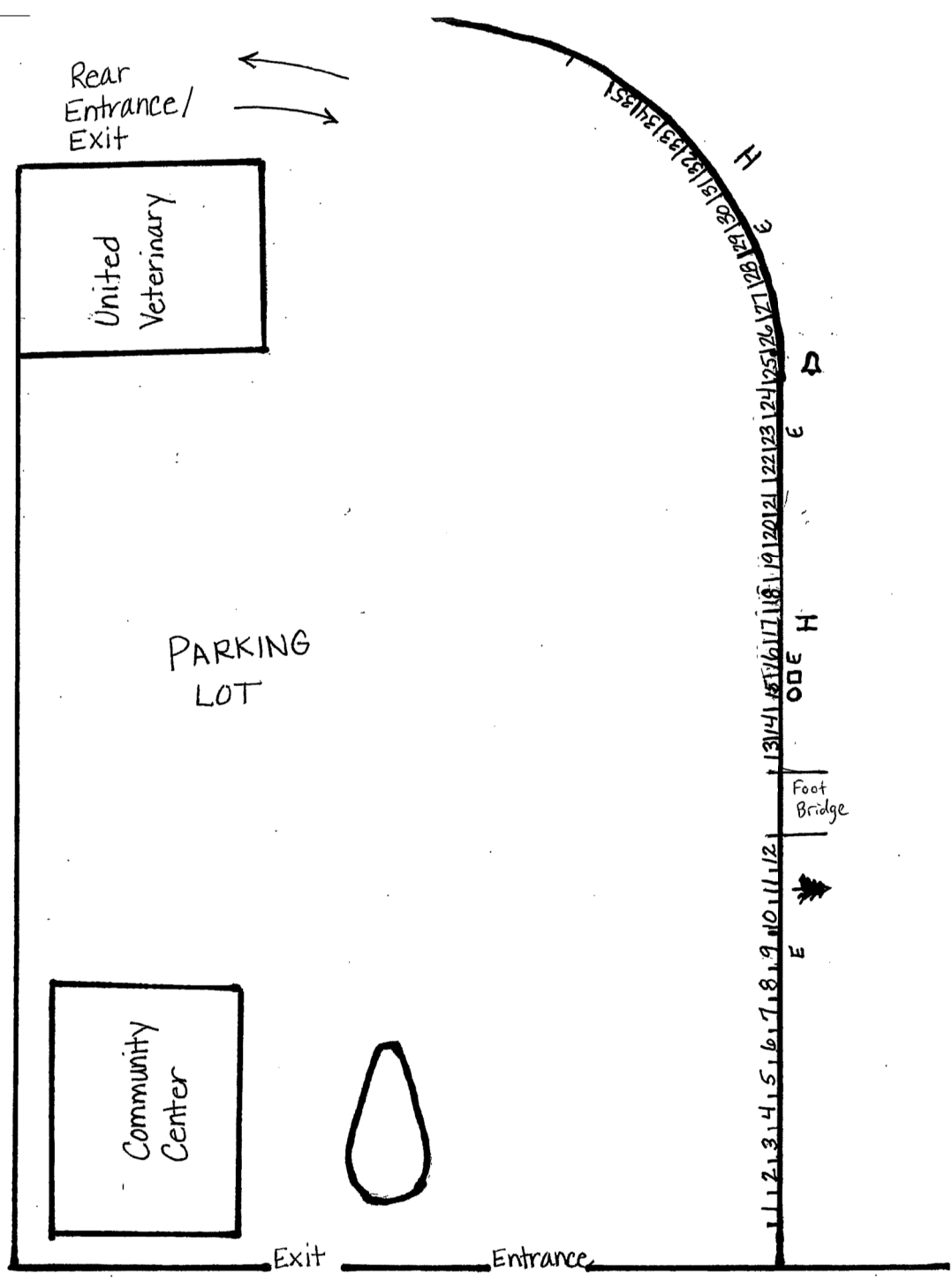
In addition, for anyone bringing baked goods, you are no longer required to have certification of a certified kitchen if your goods are considered "not-potentially hazardous." This is classified as any food that can safely remain unrefrigerated. If you are selling goods that contain cream filling, custard, cheese, meat, or buttercream frosting these are examples of items that would still require the state certification.

We also welcome local musicians/entertainers to set up during the Farmer's Market at no charge. If you know of anyone that may be interested please have them contact us! Thank you for your participation as we start this journey to grow and improve our Clintonville Farmer's Market.
